### Definitions

"Personal data" means any information relating to an identified or identifiable natural person (hereinafter the "data subject"); a natural person is considered as identifiable, which can be identified directly or indirectly, in particular by means of assignment to an identifier such as a name, to an identification number, to location data, to an online identifier (eg cookie) or to one or more special features, that express the physical, physiological, genetic, mental, economic, cultural or social identity of this natural person.

"Processing" means any process performed with or without the aid of automated procedures or any such process associated with personal data. The term goes far and includes virtually every handling of data.

"Responsible person" means the natural or legal person, public authority, or institution that decides, alone or in concert with others, on the purposes and means of processing personal data.

### Form data

If you use forms on our website, you will be asked to enter certain personal data (such as name, postal or e-mail address). As far as you use this form, the data will be forwarded to us directly and the data will be used exclusively for the purpose shown.

Any transfer or sale of your personal data to third parties will not take place unless this is necessary for executing the contract.

You have the right to withdraw your consent at any time with effect for the future. Insofar as there are no legal reasons, the cancellation or blocking takes place immediately.

### **Legal bases**

The legal basis for processing on this website is Art. 6 para. 1 lit. a, b and f DSGVO.

### **Collaboration with data processors and third parties**

If, in the context of our processing, we disclose data to other persons and companies (contract data processors or third parties), transmitting data or otherwise granting access to the data, will only occur on the basis of a legal permission (e.g. transmission of data to third parties required by payment service providers, pursuant to Art. 6 (1) (b) GDPR to fulfill the contract), your consent or based on our legitimate interests (e.g. the use of agents, webhosts, etc.).

If we commission third parties to process data on the basis of a so-called "contract processing contract", this is done on the basis of Art. 28 GDPR.

### **Transfers to third countries**

If we process data in a third country (i.e. outside the European Union (EU) or the European Economic Area (EEA)) or in the context of the use of third party services or disclosure or transmission of data to third parties, this will only be done if it is to fulfill our (pre) contractual obligations, on the basis of your consent, on the basis of a legal obligation or on the basis of our legitimate interests. Subject to legal or contractual permissions, we process or have the data processed in a third country only in the presence of the special conditions of Art. 44 et seq. DSGVO. That the processing is e.g. on the basis of specific guarantees, such as the officially recognized level of data protection (e.g. for the US through the Privacy Shield) or compliance with officially recognized special contractual obligations (so-called "standard contractual clauses").

### **Rights of data subjects**

You have the right to ask for confirmation as to whether and which data is being processed and for information about this data as well as for further information and a copy of the data according to Art. 15 GDPR. You have according to Art. 16 DSGVO the right to demand the completion of the data concerning you or the correction of incorrect data concerning you. In accordance with Art. 17 GDPR, they have the right to demand that the relevant data be deleted immediately or, alternatively, to require a restriction of the processing of data in accordance with Art. 18 GDPR. You have the right to demand that the data relating to you, which you have provided to us, be obtained in accordance with Art. 20 GDPR and request their transmission to other persons responsible. You have according to Art. 77 DSGVO the right to file a complaint with the appropriate supervisory authority.

You can object to the future processing of your data in accordance with Art. 21 GDPR at any time. The objection may in particular be made against processing for direct marketing purposes.

### **Retention period**

The transmitted personal data will be kept for 10 years in the case of a contract in accordance with §§ 238, 257 IV HGB / § 147 II AO.

The personal data transmitted via the contact form, for which further storage is not required, will be deleted after 1 month.

### **Right of information and withdrawal**

You have the right to grant consent in accordance with Art. 7 para. 3 DSGVO with effect for the future.

As far as we receive a request in text form, we will gladly inform you if and if so what personal data we have stored about your person.
